

GENDER PAY GAP REPORT

Kloeckner Metals UK is required by law to publish an annual gender pay gap report.

This is its report for the snapshot date of 5 April 2020.

- The mean gender pay gap for Kloeckner Metals UK is **-5.87%**.
- The median gender pay gap for Kloeckner Metals UK is **-18.98%**.
- The mean gender bonus gap for Kloeckner Metals UK is **-8.57%**.
- The median gender bonus gap for Kloeckner Metals UK is **-936.97%**.
- The proportion of male employees in Kloeckner Metals UK receiving a bonus is 66.38% and the proportion of female employees receiving a bonus is 73.73%.

Pay quartiles by gender

Band	Males	Females	Description
1	94.97%	5.03%	Includes all employees whose standard hourly rate places them in the lower quartile
2	88.89%	11.11%	Includes all employees whose standard hourly rate places them above the lower quartile but at or below the median

The figures set out above have been calculated using the standard methodologies used in the Equality Act 2010 (Gender Pay Gap Information) Regulations 2017.

What are the underlying causes of Kloeckner Metals UK's gender pay gap?

Under the law, men and women must receive equal pay for:

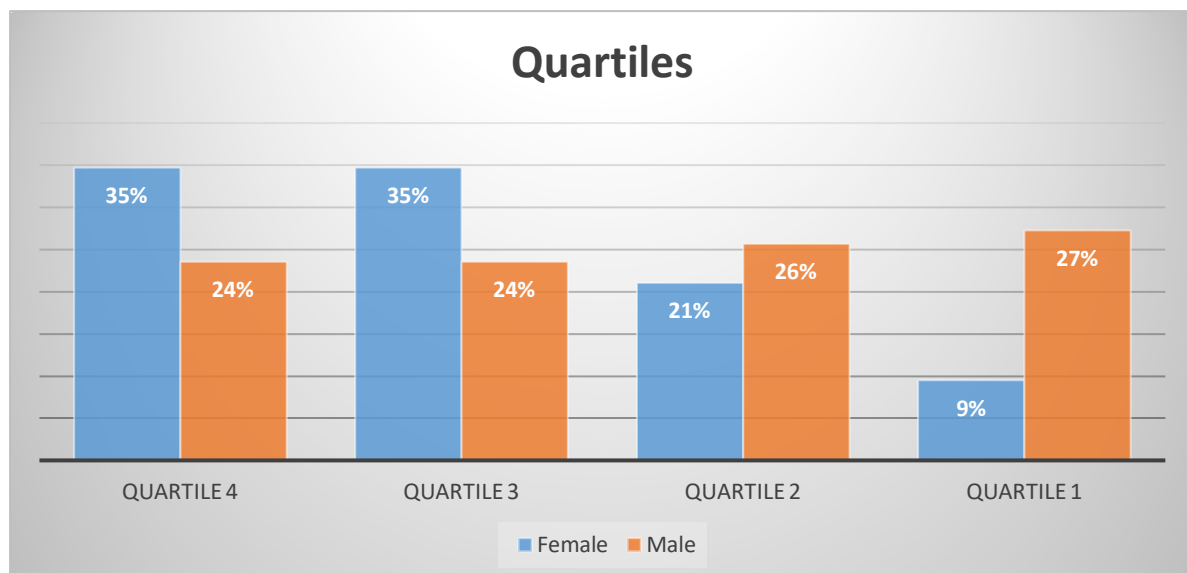
- the same or broadly similar work;
- work rated as equivalent under a job evaluation scheme; or
- work of equal value.

Kloeckner Metals UK is committed to the principle of equal opportunities and equal treatment for all employees, regardless of sex, race, religion or belief, age, marriage or civil partnership, pregnancy/maternity, sexual orientation, gender reassignment or disability. The Company has a clear policy of paying employees equally for the same or equivalent work, regardless of their sex (or any other characteristic set out above). As such, it:

- carries out pay and benefits audits at regular intervals;
- Evaluates job roles and pay grades as necessary to ensure a fair structure.

Kloeckner Metals UK is therefore confident that its gender pay gap does not stem from paying men and women differently for the same or equivalent work. Rather the gender pay gap is the result of the roles in which men and women work within the organisation and the salaries that these roles attract.

The pattern from the UK economy as a whole is not necessarily reflected in the make-up of Kloeckner Metals UK's workforce, although the Company's workforce is clearly male dominated in terms of employee numbers. We find that female employees are over-represented in the higher pay quartiles, as can be seen below:



How does Kloeckner Metals UK's gender pay gap compare with that of other organisations?

The vast majority of organisations have a gender pay gap, and we are pleased to be able to say that Kloeckner Metals UK's gap compares favourably with that of other organisations.

The average mean gender pay gap is 14.19% for all 10,827 UK employers who submitted data in the previous year. At **-5.87%** Kloeckner Metals UK's mean gender pay gap therefore favours female employees.

The median gender pay gap for all 10,827 UK employers is 11.91%. At **-18.98**, Kloeckner Metals UK's median gender pay gap also favours female employees.

The proportion of men at Kloeckner Metals UK who received a bonus in the 12 months up to 5 April 2020 was 66.38% (UK average 35.72%), while for women this was 73.73% (UK average 34.40%). The mean gender pay gap in bonus pay was **-8.57%**, while the median pay gap in bonus pay was **-936.97%**.

What is Kloeckner Metals UK doing to address its gender pay gap?

While Kloeckner Metals UK's gender pay gap compares favourably with that of organisations across the UK economy, this is not a subject about which Kloeckner Metals UK is complacent.

However, Kloeckner Metals UK also recognises that its scope to act is limited in some areas. The Company has no direct control over the career choices that an individual may make. The industry in which we operate is traditionally a male dominated one, particularly in relation to roles such as Warehouse, Plant and Machine Operatives, which form the vast majority of the Kloeckner Metals UK workforce. While the business has struggled to recruit female employees in those roles, recruiting females in areas such as sales, head office support functions and other senior positions has been far more successful, which explains why the gender pay gap figures favour the female workforce.

Kloeckner Metals UK continues to promote gender diversity in all areas of its workforce, aims to identify any barriers to gender equality and identifies priorities for action, by analysing

- the proportion of men and women applying for jobs and being recruited;
- the proportion of men and women applying for and obtaining promotions;
- the proportion of men and women leaving the organisation and their reasons for leaving;
- the number of men and women in each role and pay band;
- the proportion of men and women who return to their original job after a period of maternity or other parental leave; and
- The proportion of men and women still in post a year on from a return to work after a period of maternity or other parental leave.

Kloeckner Metals UK is committed to reporting on the gender pay gap and the progress that it is making on an annual basis.
